

- 1) The Settlor have this day transferred and given unto the trustees a sum of Rs. 1,000/- (Rupees One thousand only) to be held upon Trust together with all the income arising therefrom for the intent and purpose and objects herein contained.
- 2) The name of the Trust shall be AASARE. Trust shall be at 217, Shanthi Nilaya, 3rd Cross, New Thippasandra, HAL III Stage, Bangalore - 560 075 and/or such other places in India as the trustees may determine.
- 3. OBJECTS of the trust shall be :
- (a) To support, maintain, assist and promote the interest of the physically and mentally handicapped (especially the visually handicapped) in every way. For this purpose physically handicapped will mean and include persons of proven dis-ability recognised such under any statute or rules of any Government or public body as well as those whom the trust recognises as such having due regard to the impairement suffered by them of limbs, parts the body, eyes, ears etc. , which substantially reduce ability to undertake gainful employment. of their
- (b) To start, run, support and maintain schools and colleges, vocational centres, training handicapped persons so as to enable them to lead their lives dignity as respected members of the community.
- (c) To promote acceptance of such handicapped persons in society, employment and other various walks of life.

(d) To do all that is necessary and incidental for the purpose of achieving the objects in (a) to (c) above.

## N.B. :

The Trustees in their discretion may apply or accumulate in India as permitted by law the income and the funds of the trust for any or all of these objects, as they may determine, but for no other purpose.

- (4) The benefits of the trust will be available to the members of the public (disabled) without any distinction of caste, community or creed. The trustees shall not derive any benefit at any time from the trust funds and at any event neither during existence of the trust nor at any other time will any property of the trust be distributed among or made over to the trustee(s).
- (5) The powers of the trustees as contained herein and generally shall be exercised in such a manner as to ensure that the investments of the trust funds shall be made only in accordance with the provision of section 11(5) of the Income-Tax Act, 1961 and further the trustees will ensure at all times having due regard to the provisions of Section 13 and other relevant provisions of the Income Tax Act, 1961 that the income of the trust will be exempt under the relevant provisions of that Act.
- (6) The Trust hereby created shall be irrevocable.
- (7) The Term Trust Property shall be and include the schedule property set apart by the settlor and further grants, donations and contributions and/or property movable or immovable, that may be made by the settlors by the others from time to time and other accumulations and accretions thereof in whatever forum they may be varied from time to time.
